

# Online Internet Service-Land Registry

## Access to pdf Images-Current and Historical Instruments

### 1. Plans

SNB currently holds 150,000 registered Subdivision or Survey Plans on file in our 13 Registry offices. We have scanned images of these plans from the existing microfilm copies. Approximately 85% of the plans on film that were scanned are available online.

### What is a “Hyperlink”?

A Document or Plan number that appears as a different color and activates another screen when clicked on.

**Note** - If there is no Hyperlink on the plan number the image is not currently available.

Users may also request a plan image by email, or a large format paper copy may be mailed to them by selecting the desired option on the **Image Information screen**.

The fee for this service is

- o View = No cost
- o Email = \$2.00 / plan
- o Hardcopy plans : single page is \$5.00 + \$3.00 (Shipping&Handling) = \$8.00  
For each additional page the price increments - \$5.00 (i.e. 2 pages = \$13.00)

## 2. Documents

Viewing of documents is available in multiple modules of PLANET;

“**Real Property Information - Parcel Information**” screen - by clicking on the hyperlinked Document number.

**Note** - If there is no Hyperlink on the document number it could be available in the Historical Documents under the Search Registration Index.. [https://www.planet.snb.ca/PLANETDB/mnquery\\$.startup](https://www.planet.snb.ca/PLANETDB/mnquery$.startup)

“**Registration Index -Document Information**” screen – by clicking on the hyperlinked Document Number.

**Real Property Information - Parcel Attribute Database – Search by Document Image**” – by clicking on the hyperlinked Document Number in the “Query Results” screen.

Users may also request a document image by email by selecting the desired option on the “NEW” Image Information screen.

The fee for this service is

- o View = No cost
- o Email = \$2.00 / document

A copy of all newly registered documents will be scanned internally. The expected turn around time for these images to be on-line is two business days from time of registration.

**NOTE:** If you click on a hyperlink for a document number which is “associated” with another document (Eg: A mortgage that has an associated discharge against it) you will receive the following alert:

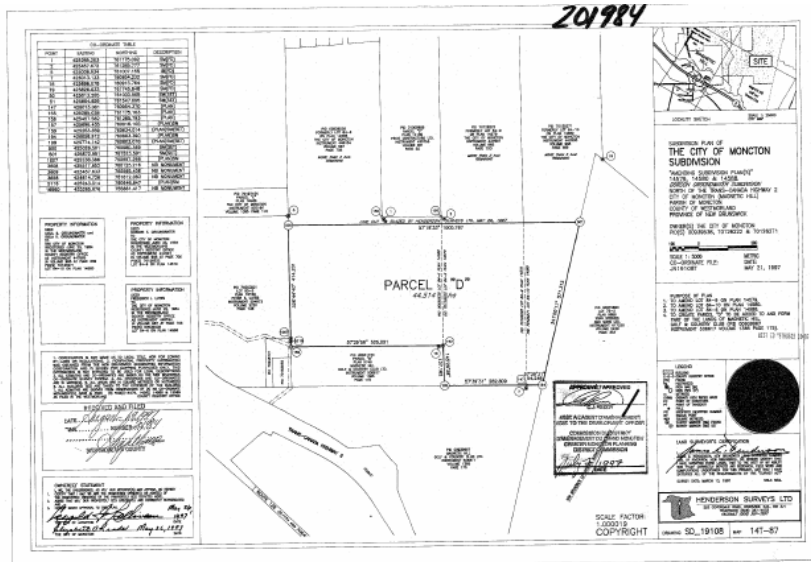
